
# The Embassy of Switzerland to India and Bhutan, Switzerland Global Enterprise and the Society Switzerland Bhutan are organising a business trip to Bhutan from 04 - 07 June 2019.

Switzerland and Bhutan share a very special and close history which dates back to the 1950s, and goes back to the strong and exceptional friendship between His Majesty, King Jigme Dorji Wangchuck and Mr. Von Schulthess, a well-known Swiss entrepreneur.

Over the years, many joint projects in agriculture, forestry, business, health, education have been built up. And to further strengthen the relationship between the two countries, Switzerland established a new Swiss Consulate in Thimphu on 1<sup>st</sup> August 2018.

During many high level meetings, both the countries discussed the wish to increase possibilities for Swiss companies to get to know more about Bhutan and its business opportunities. And from there, the idea of this Swiss business delegation trip to Bhutan was born.

It gives us great pleasure to invite companies from Switzerland, Liechtenstein and related companies in India to join us for this «first ever Swiss business delegation trip to Bhutan», and to experience for yourself the business opportunities that Bhutan offers.







# 1. Why consider doing business in Bhutan?


While Bhutan itself has a small domestic market, opportunities exist for Swiss and Liechtenstein small and medium-sized companies as well as for larger transnational corporations. Additionally, Swiss companies based in India can enjoy benefits arising out of the location advantage.

- The free-trade agreement between Bhutan and India provides companies automatic access to the Indian market. There is also preferential access to the sub-continent through the South Asian Free Trade Agreement.
- Bhutan has affirmed its clear commitment to diversify the country's economy, to foster private-sector development, and to focus on legislative and institutional reforms, in order to improve the environment for businesses to flourish.
- According to the World Bank 2018 Doing Business Report, Bhutan is one of the two top performing economies in South Asia.
- Availability of competitively priced energy generated from Bhutan's abundant hydropower resources is ideal for industries with a high level of power requirement.
- Bhutan is a safe country with very low levels of crime and corruption, a strong and stable political system, and rich in both human and material resources.

# 2. What can the participants expect?

During this trip, participants can expect a programme covering the following elements, with the possibility of requesting tailor made options:

- Sector insights with important private companies and public sector organizations.
- B2B session with potential business partners and other relevant companies.
- Interactions with decisions makers and key industry bodies.
- Conversations with subject experts on topics such as the history, business culture, role of Buddhism and the concept of Gross National Happiness.
- Possibility of interactions with high ranking officials of the Royal Government of Bhutan.
- Site seeing including museums, important Buddhist sites, monasteries. Possibility of suggesting an itinerary for those who wish to stay longer for tourism


- 4 to 5 hours of site seeing, hikes, monasteries, museums such as:

  - The Royal Textile Academy of Bhutan, Tashichho Dzong, Thimphu Chorten, Changangkha Lhakhang, National Institute for Zorig Chusum



# 5. Bhutan Sector Overview and Opportunities

# Agriculture, organic food, food processing and sourcing:

- With a climate, varying from subtropical in the south to alpine conditions in the North, a vast range of crops can be grown in Bhutan. It is known as the land of medicinal herbs, and has a rich tradition of healing (*sorig*) that shares the same characteristics as Ayurveda and nutraceutical products.
- 60% of the population is engaged in the agriculture sector, comprising 17% of the GDP as the largest sector – approximately Nu 20 billion (CHF 0.28 billion). The majority of Bhutan's food is imported from India and Thailand and tends to be highly processed.
- Commercialization of agriculture is identified as a priority development goal. Institutional reforms to attract investments include providing 10-year income tax holiday, easier access to finance and public land. Businesses also enjoy exemptions on sales tax and import duty on farm machinery and inputs.

Opportunities: Agri and food processing machinery, organic food and horticulture, scaling up of the green tea plantation in central Bhutan, craft beer and bottled water, dairy processing, essential oils, food testing and certification, farming of medicinal plants and edible flowers.

#### Construction, infrastructure and engineering

- As a developing nation, infrastructure projects are a perpetual feature of the Bhutanese landscape. The construction sector accounts for 16% of the GDP. In addition to roads, bridges and other public works that cater to a growing population, hydropower projects are the primary driver of infrastructure investment in Bhutan.
- With the focus on developing multiple large hydropower projects by 2020, significant investments have been made into auxiliary sectors around these projects such as roads, shops, restaurants, housing and entertainment. With more hydropower projects still in the pipeline, and with newly prosperous businesses and individuals continuing to build homes and offices, the construction sector is likely to grow further.

Opportunities: Expertise and consulting services for ropeways, bridge construction, tunnelling, rock fall protection and other mountain infrastructure. Construction equipment and materials, heating and insulation technology, energy efficient buildings, quick drying cement, tools, hand tools, and door/window/kitchen/bathroom fittings and fixtures.

# Information Technology (IT)

- After decades of looking to IT as a panacea to physical challenges like rough terrain and a small
  domestic market, a critical mass of IT professionals, entrepreneurs and policy support has begun to
  create an enabling environment. Plus, where broadband internet penetration struggled to gain traction,
  the ubiquity of smartphones has also proven key in spurring IT-enabled growth.
- The Thimphu TechPark is currently enjoying a run of success in attracting international firms to its campus and promoting the development of start-ups through trainings, mentorships, idea competitions and workspace support. With its present 50,000 square foot space fully occupied, and a second facility is under construction.
- Sector specific incentives for the IT sector include a ten-year tax holiday for the operation of IT/Business Process Outsourcing (BPO) units.

Opportunities: Business Process Outsourcing, Knowledge Process Outsourcing, block chain, transaction processing and data centres.







#### Banking, financial Services and insurance

- Bhutan has five banks: Bank of Bhutan, Bhutan National Bank, Bhutan Development Bank, T Bank, and Druk PNB. Three non-banking financial institutions – National Pension and Provident Fund, Royal Insurance Corporation of Bhutan, and Bhutan Insurance Limited are also sanctioned to provide loans. Together, the assets of these institutions total Nu 163.77 billion (CHF 2.34 billion)
- All lending by these FIs are mostly collateral-based, leaving a critical gap in funding for start-ups and small businesses. While a few civil society organisations have implemented microfinance programs and zero interest loans to promote entrepreneurship, the need for alternative models of finance and investment continues to be a challenge.

Opportunities: The Royal Monetary Authority of Bhutan is keen to explore digital banking, fintech and use of new technologies such as block chain. Technology partnership, providing external commercial borrowings to Bhutanese companies and potential collaboration in the cottage and small banking sector.

#### Healthcare, pharma and medtech

- The Government provides free healthcare across the country through its 27 hospitals, 208 basic health units, 519 outreach clinics, and 49 indigenous units. There have been continuous efforts by the Ministry of Health to improve and modernise the healthcare system and services.
- An interesting aspect of the health system is the fusion of traditional and modern medicine. It is not uncommon that a patient would consult both a modern and indigenous physician. For the latter, about 300 out of 600 identified medicinal species in Bhutan are commonly used to prepare drugs.
- According to the FDI Policy, pharmaceuticals have been identified as a priority activity by the Government of Bhutan and FDIs are allowed up to 74% ownership.

Opportunities: Pharmaceuticals production and export, sourcing for nutraceutical production, medical equipment and technology. There are also opportunities to supply laboratory testing equipment and medical devices to the Ministry of Health.

#### **Environment and clean technologies**

- Bhutan, known for its policies concerning environment, is perhaps the only Carbon negative country in the world.
- One of the major focus areas in the country is the development of a green and sustainable economy. Fiscal incentives such as the tax rebate of 15%, is provided for environment friendly projects.
- Waste management is a priority activity, and other technologies such as green buildings are being encouraged within the growing construction sector in Bhutan.

Opportunities: Clean tech and energy efficient products and services, waste and waste management, environmentally friendly building materials, wood working industries. Essentially, clean, green and sustainable business ideas are required.







#### **Consumer goods**

- Bhutan is a niche market has a small population of 735,553 and places restrictions in FDI wholesale or retail trading. However, due to its nascent manufacturing sector, almost all of consumer goods are imported in Bhutan mostly from India or Thailand.
- With a growing economy and increasing prosperity, there is now a segment of consumers who are demanding high end goods. Further, with a growing number of tourists, there is an opportunity for duty free goods as well.

Opportunities: Export of consumer and retail goods through Bhutanese distributors or in partnership with Bhutan Duty Free Corporation, for consumer and destination goods such as watches, knives, chocolates, luggage, and mountain/ trekking gear.

#### **Travel and Tourism**

- In 2017, Bhutan had 254,704 visitors for tourism packages such as culture, adventure, spirituality, wellness or nature. While Bhutan's unique culture of high end tourism certainly draws in visitors, the figures also speak to a lack of innovation in the tourism industry to provide other attractions.
- The country's rich nature preserves and wild rivers, for instance, seem obvious draws for adventurous travellers. Its relatively untouched environment make it an ideal wellness destination and its deep Buddhist roots offer many interesting options as well.

Opportunities: Investment in tourism infrastructure has steadily grown in the last two decades. However, the potential to capture a niche market continues to exist. Specialized tourism products like wellness resorts, four and five star hotels and high end resort, MICE tourism, corporate retreats and other adventure and nature based recreational services.

The Kingdom of Bhutan is a constitutional monarchy of about 787'000 people. Landlocked between China and India, the country covers 38'394 km2 (slightly smaller than Switzerland), mainly covered by forests and mountains. The long-term vision of Bhutan's Government is based on the concept of the Gross National Happiness which strives for a democratic, internationally recognized, and socially equitable society.

# **FDI in Bhutan**

- Of the 64 foreign direct investment (FDI) projects worth Nu 34 billion (CHF 0.49 billion) since 2002, 64% have been from the Asia region, 21% from Europe, 11% from North America, and 4% from Oceania
- FDI sector breakup: 42% (Hospitality), 15% (IT/ITES), 11% (Dairy, agro, water bottling and beverage projects), 5% (Financial services), 7% (Power intensive manufacturing firms) and others in services and manufacturing.

# **Cost of Doing Business in Bhutan**

- Land (lease rent):
  - Major Commercial Hubs: \$16/m sq per month (CHF 16 /Kwh)
  - Industrial Estates: \$0.06/sq ft. per year (CHF 0.06/Kwh)
- Electricity: US\$0.04/Kwh (CHF 0.04/Kwh)
- Water: US\$0.11/m sq (CHF 0.11/ m sq)
