SPANISH FINTECH MOMENTUM

The Spanish Fintech ecosystem has shown an incredible performance in the last months, up to the point that 2017 could be considered the dawn of the sector in the country. The number of start-ups increased by 117 to almost 300, a 41% more since 2016, showing signs of the innovative potential of the sector, which has been driven by the high growth of segments such as Crowdfunding, Personal Financial Management and Enterprise Financial Management.

The dynamism observed in the Spanish Fintech ecosystem highlights the integration of multiple new specialized players, which offer very specific products and services within the financial industry's value chain.

Switzerland Global Enterprise and **Swiss Business Hub Spain (SBHS)** consider that the sector offers now great opportunities for Swiss companies. Therefore, together with the **Embassy of Switzerland to Spain and Andorra**, we are organizing the event 'Fintech Switzerland' in Madrid.

THE SWISS PERSPECTIVE AND OPPORTUNITIES

The event, with a strong focus on *swissness* promotion, will pursue two main goals:

- Promote Switzerland as a business location for Spanish fintech companies, providing relevant information on the country and the advantages it offers to global Spanish enterprises.
