SWISS OPPORTUNITIES IN U.S. WATER QUALITY

Swiss business delegation trip around water quality in the Midwest





1. INTRODUCTION

WEFTEC is the annual conference of the Water Environment Federation and is the largest show in North America focusing on drinking and wastewater quality and will take place from October 2-4 in Chicago, IL. In 2022, around 800 exhibitors and 18,000 visitors from numerous countries attended the show and connected on business opportunities around water quality in the U.S. In 2023, Swissenviro is hosting a Swiss Pavilion for a minimum of six Swiss water companies, incl. SMEs and startups, and over 10 Swiss water companies will exhibit their specific solutions at their independent booths.

Following WEFTEC, the Swiss Business Hub USA offers Swiss exhibitors at WEFTEC the chance to learn about business opportunities in water quality in the Midwest and the U.S. as part of a short fact finding mission from October 4-6 to Chicago and Milwaukee. Both cities and the Midwest are ideal landing pads for Swiss companies in water quality looking to enter or grow in the U.S. market. Chicago, IL and Milwaukee, WI are both located on Lake Michigan which is one of the U.S. Great Lakes. The Great Lakes hold 90% of U.S. freshwater and decision-makers are looking for solutions to monitor, track, maintain and preserve water quality, infrastructure and the water resources. Switzerland holds 6% of Europe's freshwater and Swiss companies have developed numerous solutions which match current needs in the Midwest around freshwater. In addition, Chicago is positioned between two large river basins and numerous canals crisscross the city which is why the city is considered a "water city". Chicago is also the economic and logistical center of the Midwest which hosts 36 Fortune 500 companies and numerous manufacturing, insurance and tech companies and local companies, water industry experts and public departments are keen to learn about Swiss water solutions. Milwaukee, WI is home to a cluster of over 200 water-related companies and the Water Council in Milwaukee, WI is a global leader with over 45 (international) companies in water technology and innovation, providing an ideal starting point for Swiss companies looking to expand to the Midwest and U.S. markets. Swiss companies will learn about current and upcoming water quality projects in both cities, the Midwest and the U.S. and connect with local industry experts, decision-makers, researchers and innovators.

2. Goals

Goals of the fact finding mission to Chicago and Milwaukee after WEFTEC are to:

- 1. Provide the Swiss delegation an overview over current water quality projects in Chicago, Illinois, Milwaukee and Wisconsin on a municipal and state level and in the U.S. on a federal level and emphasize to how Swiss companies can be part of potential projects in the aforementioned places.
- 2. Support Swiss companies with getting an understanding of how their specific solutions match project-specific needs, i.e. whether, where and to what extent the technology is sought after in the U.S. market.
- 3. Connect the Swiss delegation with local and global water companies headquartered in Chicago or Milwaukee, innovators at research institutions as well as with local experts who are experienced and well-connected to support international (Swiss) startups and SMEs with scaling in the U.S. market.
- 4. Build a peer community of Swiss water communities interested in entering or growing in the U.S. market and facilitate an exchange of best practices among these as well as to establish local partnerships with the Swiss community in the Midwest.

Name of organization	Description
Choose Milwaukee (water)	Choose Milwaukee is the Milwaukee 7 Regional Partnership which markets the region in southeastern Wisconsin around Milwaukee to companies looking to expand operations. The organization is aims to simplify the relocation or expansion process and provides information on tax or other economic incentives of potential interest to Swiss companies. Choose Milwaukee is in close contact with 5 of the 11 largest water firms which are located in Milwaukee, e.g. Badger Meter, Kohler and A.O. Smith. GE and Pentair have also formed a global residential water filtration joint venture with its global headquarters in the Milwaukee Region.
Current Chicago	Current Water is an innovation hub around clean water which was launched in 2016 together with the City of Chicago, the Water Reclamation District of Chicago and World Business Chicago. Current evaluates new technologies in water management and builds partnerships between businesses, government and researchers (more here).
Department of Water Management, City of Chicago	The Department of Water Management delivers nearly 1 billion gallons of drinking water to residents of Chicago and suburbs daily and removes waste water and storm runoff through the sewer system. The Department aims to deliver high quality drinking water to the Chicago region while also protecting Lake Michigan's freshwater reserves. For instance, the Department aims to monitor and reduce lead from residential tap water as 80% of Chicago homes have water connections made of lead.
Illinois Environmental Protection Agency (EPA)	The Illinois EPA is the regional office of the U.S. looking to "safeguard the state's natural resources from pollution". The agency's Bureau of Water makes sure that Illinois' public water systems provide high-quality water and meets all regulatory requirements and monitors the quality of the state's surface and groundwater resources (among others). The Bureau provides a number of loan and grant programs to upgrade existing and build new wastewater, storm water treatment and public water supply infrastructure.
Intersect Illinois	Intersect Illinois is an economic development agency looking to strengthen business and R&D investments into the entire state of Illinois. For that purpose, Intersect Illinois builds partnerships between the state's over 2,000 internationally-owned businesses and international companies interested in expanding or relocating to the state and provides international companies with information on economic assistance available to them.
Metropolitan Water Reclamation District (MWRD) of Greater Chicago	The MWRD of Greater Chicago is a special-purpose district created by the state of Illinois for the reclamation and treatment of wastewater and flood water abatement in Cook County, Illinois' most populous county. For instance, MRWD reversed the flow of the Chicago River Systems in the early 1900s and was involved in the construction of a complex tunneling system around Chicago. MRWD also works with innovative companies on the recovery and reuse of resources, e.g. of nutrients removed from wastewater.
Milwaukee Water Works	The Milwaukee Water Works is owned by the City of Milwaukee and purifies water from Lake Michigan to provide fresh drinking water to almost 900,000 people in 16 surrounding communities. North Point Water Tower was built in 1873 and is Wisconsin's first public waterworks. Swiss companies can connect with representatives of Milwaukee Water Works and learn about potential partnership opportunities (more here).



Swiss-American Business Council (SABC)	The SABC creates and promotes the Swiss-American business community in Chicago and the U.S. Midwest through events, networking and information exchange.
UL Solutions	UL Solutions is a global safety science company headquartered in Northbrook, Illinois. The company is composed of three organizations which are active in 100+ countries: UL Research Institutes, UL Standards & Engagement and UL Solutions. UL works with numerous international companies across industries in the U.S. and can provide further information on certifications required for Swiss water companies interested in entering the U.S. market.
Water Council Milwaukee	The Water Council is a nonprofit organization which aims to solve water challenges by driving innovation in freshwater technology and advances in water stewardship. The Water Council has turned Milwaukee into a global destination for water technology and innovation and operates the Global Water Center, a 98,000 square foot facility with labs and coworking spaces for universities, water companies and startups. In 2023, more than 45 companies from around the world use the space at the Center and over 30 companies have moved to Milwaukee as a result of it. The Water Council also operates the BREW 2.0 Technology Accelerator, a next-stage accelerator which helps young companies build their local connections and grow their company's capacity. Applications for the 2024 cohort open in November 2023 so Swiss startups can learn about the opportunities at the BREW Accelerator for the coming year (more here).
World Business Chicago	World Business Chicago is the City's economic development agency and builds connections between foreign and domestic companies, researchers and the public sector, including around innovation & technology and food manufacturing and efficient and sustainable water management. World Business Chicago can introduce some of the unique opportunities of doing business in Chicago and Swiss companies can connect with representatives of the agency on an informal level (more here).
